

Regulations of the student car park of the Faculty of Philology of the University of Lodz

§ 1

The Regulations lay down the rules for the use of the unguarded car park for students of the Faculty of Philology of the University of Lodz.

§ 2

(1) In order to use the car park referred to in paragraph 1, a student of the Faculty of Philology must have a valid entry card issued by an employee of the administrative section of the Faculty of Philology.

(2) The entry card will be issued on the basis of an application sent by e-mail to parking.filologia@uni.lodz.pl and presentation of a valid student ID card.

(3) The car park regulations and the card application are available on the website of the Faculty of Philology (filolog.uni.lodz.pl).

(4) Upon receipt of the access card, the student is given these rules and regulations for inspection and signs a declaration of acceptance of their conditions.

(5) A student is entitled to have only one access card. After the end of the semester session, entry cards will be verified in the USOS system. If a student's status expires, the card will automatically be blocked.

(6) The transfer of cards to third parties is prohibited.

(7) The card does not entitle the holder to use the main car park, which is intended for visitors and employees of the Faculty of Philology (entrance from Pomorska Street).

§ 3

(1) The car park is secured by an entry barrier, accessible 24 hours a day, unguarded;

(2) Having an entry card makes it possible to leave a vehicle in the car park provided there are free parking spaces.

(3) Traffic regulations apply on the car park premises.

(4) Users of the car park are liable for damage resulting from vehicle traffic on the car park premises in accordance with generally applicable laws;

(5) Owners and users of vehicles leave them in the car park of the Department at their own risk and the manager is not responsible for damages resulting from events beyond their control.

(6) The car park is equipped with CCTV, recordings from the monitoring system of the facility and the adjacent area may be made available to law enforcement agencies upon their written request and serve as evidence in a case, in the event of a connection between the case and possible incidents in the parking area.

(7) Drivers of vehicles are required to park in designated parking spaces.

(8) In the car park it is categorically prohibited to:

(a) Stop and park on access and fire roads and other places where left vehicles may prevent or obstruct the passage of emergency services and police cars.

- b) Park in passageways, places clearly marked as prohibited from parking, access roads marked with a prohibition sign and park in a way that prevents or impedes the free entry and exit of other users of the car park or causes obstruction or danger to traffic.
- c) Smoke and use naked flames, drink alcohol, store fuels, hazardous substances and empty containers thereof, refuel and repair vehicles, leave vehicles with the engine running.
- d) Leave the vehicle for longer than 48 hours.

§ 4

(1) The student car park of the Faculty of Philology is an unguarded car park and the Faculty of Philology shall not be liable for damage to vehicles or their equipment caused by third parties or force majeure.

(2) The Faculty of Philology may - without prior notice to holders of entry cards - limit or exclude the availability of the student car park, in particular in connection with renovation work or the organisation of outdoor events.

§ 5

If a student violates the provisions of these regulations, the administrative department of the Faculty of Philology may deactivate the entry card.

§ 6

Upon graduation, the card should be returned to the administrative department.
